However, IAF representatives recently meet with GFSI Board members in Berlin which resulted in an agreement on a path forward. He indicated that Boards Members are committed to the MLA with GFSI.		
		He continued that the guidance document was being revised (version 7) and the hope was to complete the version by the end of the year.  GFSI will be further discussed at the WG Food meeting on Sunday. Izabela Palgan is the GFSI representative to IAF. From GSFI's perspective, auditor competence is the most critical concern.		
06.5	Global G.A.P- Food Safety (Fekete)	Andras Fekete provided an overview of the Global GAP, a member based organization and its programs. He explained that Global GAP is a retail based non-profit organization with some 160,000 retailers globally. It has a number of programs, with numerous un processed food sectors, the Integrated Farm Assurance being the focus of IAF recognition. It presently has 30 accreditation bodies and 140 certification bodies offering the program and 6 ABs that are inactive but will eventually offer accreditation recognized by the program.		
		Other Global Gap standards include a food safety, chain of custody, feed, livestock transportation, and social practises.
