He hi-lighted the difference between Working Groups (WG) as long term programs versus Task Forces (TF) as project focused, e.g. document development. He also mentioned the voting procedures where each IAF member is allowed only one vote regardless of the number of participants attending.</p>

05.1.1	WG Management System Certification (ISO/IEC 17021) (Gillespie / Gignac)	<p>Guillaume Gignac provided a presentation on their meeting. The Terms of Reference was noted. He indicated that they have 30 names on their revised membership list, however, 80 participants attended their meeting. He continued that they would be revising their membership list.</p> <p>The majority of the meeting time was spent addressing and preparing responses to the discussion papers submitted for the TC Meeting. They also discussed the Consistency Forum in preparation for the TC discussions. There was also discussions regarding the IAF MD17 on Witnessing.</p> <p>Since most of the half day meeting was devoted to last minute discussion papers it was decided in the WG that their next meeting will prioritize the agenda items and then address discussion papers if there is time.</p> <p>The WG also submitted a proposed TC Resolution for consideration regarding the transition of ISO/IEC 17021-3:2013 to ISO/IEC 17021-3:2017.</p> <ul style="list-style-type: none"> <li>• <b>IAF Resolution 2017-## – Transitional Arrangement for the Revision of ISO/IEC TS 17021-3:2013 to ISO/IEC 17021-3:2017-</b> The General Assembly, acting on the recommendation of the Technical Committee, resolved that the transition period for ISO/IEC 17021-3:2017 <i>Conformity assessment — Requirements for bodies providing audit and certification of management systems — Part 3: Competence requirements for auditing and certification of quality management systems</i>, will be two years from the date of publication of the revised standard (<i>i.e.</i> 31 March 2019).</li> </ul> <p>In regards to the resolution there is a new policy of ISO, to only publish the month not the day of publication. 		<p>There was some discussion concerning the need to have a resolution for a transition period that was the IAF default period of two years. It was suggested that a resolution provide a means to publish the transition deadline so that the issue was clarified for everyone.</p> <p>The WG requested a full day meeting as there was a need for extra time to deal with discussion papers as well as being proactive with other related issues.</p>		<p>Want a full day meeting want to be proactive.</p>
05.1.2	<p>WG Product Certification Accreditation (ISO/IEC 17065) (Moliski / Kotaro)</p>	<p>Paul Moliski reported that their WG had 40 participants which included representatives from all Regional Bodies as well as ABs and CBs and vested interests.</p> <p>Their first agenda item was to update their membership list. To this end they requested a copy of the last membership list from the secretary.</p> <p>Regarding the Terms of Reference, the WG concluded that they need a mechanism to liaison with other TFs and WGs. They requested a copy of the terms of reference of all WG/TC. Another suggestions was to provide a short meeting period to have all conveners meet before/after the WG/TC meetings.</p> <p>Paul continued that Brahim Houla of GAC provided the WG an excellent presentation on halal product certification. IAAC and PAC also presented updates on their programs both including deliberations on scoping of Product Certification.</p> <p>The WG reviewed their survey results on implementation but their TF but had not performed any further analysis to date. The WG will propose a mechanism in the future to address any issues from the survey.</p> <p>Regarding a discussion paper, sent directly to WGPCA from COFRAC, regarding consultancy activities and ISO/IEC 17065 from COFRAC, the WG discussed the questions relating to consultancy and prohibited activities of the CAB for maintaining their impartiality. The WG did not come to a recommendation for the TC, instead the WG proposed to hold a half day workshop during the next IAF GA meetings in Vancouver to analyse case studies, exchange views and share experiences relating to the ISO/IEC 17065 requirements. 05.1.3	WG Person Certification (ISO/IEC 17024) (Woodley / Sheehan)	<p>Cynthia Woodley began her presentation with the Terms of Reference for this WG. Her membership list includes 70 members, however, 38 participated at this last meeting.</p> <p>The WG continued their work on the ISO/IEC17024 implementation survey. A sub group that had been formed to perform a deeper analysis had not yet completed their task. The WG decided to re-assign the task with a goal of completing it in the next few months to prepare for the workshop in Vancouver.</p> <p>The WG had previously requested a full day workshop on the implementation of ISO/IEC 17024 at the next general assembly in Vancouver (October 2017). The workshop will be designed to prevent the need for a guidance document on ISO/IEC 17024. They plan to audio tape the workshop with detailed minutes (not videotape) for future reference.</p> <p>A discussion paper submitted, directly to the WG Persons by RvA, resulted in an alert by IAF that such conflicts would need to go the Joint ISO IAF ILAC Committee (JSC). However, the WG did discuss the interpretations and agreed that while training is an acceptable recertification activity, it does not absolve the CB from confirming the continuing competence of the certified person.</p> <p>The ISO/CASCO representative indicated it could be possible to propose additional wording to refine the CASCO clarification to address the concerns. The additional wording would make it clear that acceptance of any particular activities does not absolve the CB from fulfilling the requirements of the standard. The WG agreed this would likely resolve the issue and no further action would be required. 5.1.6	<p>WG Medical Devices (ISO 13485)            (Ramaley / Nakagawa)</p>	<p>Azusa Nakagawa provided an oral report on the WG activities.</p> <p>She first noted that IAF MD 8 and 9 were under revision to include a new table. The 60 day IAF member comments were reviewed but a significant percentage were outside the scope of the amendment to the document. She continued that these other comments would be revisited at the time of the next major revision to the documents.</p> <p>She proposed an application date of twelve months for the present revision.</p> <p>The next revision of ISO 13485 would address the lack of qualified medical devices auditors</p> <p>Grant Ramaley provided a brief presentation on a proposal to address the issue of a lack of qualified medical devices auditors. He noted that with some 26,000 certificates in the global market the demand for auditors has increased beyond the present supply. 05.2.2	TF Control of Entities Operating on behalf of Accredited Certification Bodies (Savov / Houla)	<p>Ivan Savov provided a summary of the TF's background. It was established in 2011 to develop an MD on control of franchises of CBs and then redefined as a MD on control of entities operating on behalf of accredited certification bodies.</p> <p>The draft document was reviewed with the 30 day TC comments and then the 60 day IAF member comments at this meeting.</p> <p>The IAF member 60 day review raised a number of issues based on the comments related to the purpose and scope of the document, the TF focused on these issues and reviewed the document from that perspective. The scope was clarified in that the MD will now only apply to MSC accredited CABs only. The entire document was reviewed considering the scope clarification and all inconsistencies resolved.
